ANNUAL CONFERENCE 2012 REPORT

This year's conference took place on Tuesday 12th June 2012 at the GLO Centre in Motherwell. Over 150 delegates were in attendance all representing local pensioners' organisations, trade union retired members sections, as well as individual pensioner members from throughout Scotland. As always, their continued support and interest in the SPF's campaigning work was gratefully received.

Due to bereavement, the SPF Chair, Eric Souter, was unable to attend the conference and was instead represented by Margret Murdoch, a past Chairperson of the SPF. Margaret welcomed the delegates to conference and introduced Provost James Robertson to deliver the Vote of Thanks on behalf of North Lanarkshire Council.

Civic Welcome

In his address, Provost Robertson warmly welcomed all delegates to the GLO Centre and conveyed his delight that the SPF were celebrating their 21st birthday in the town. The Provost applauded the SPF for their continued work and support on behalf of Scotland's pensioners and went on to deliver

a rundown of the SPF's work and achievements over the past 21 years and finished his address by calling for more older people to take up the mantle and fight for their rights because together they are a force to be reckoned with and remarked grows ever stronger, with pensioners making up 1/6 of

Glasgow's population alone.



Due to urgent business, the scheduled speaker Nicola Sturgeon was unable to attend the conference and was substituted by John Storey, Head of the Older People's Unit at the Scottish Government.

John informed delegates that the Scottish Government took the needs of older people in Scotland very seriously and indicated that much work had been done with older people's organizations to ensure that they were respected, consulted and included and recent reports published reflected this. John also discussed the need for stronger intergenerational links to be established and hinted at his dismay that the "See the Person, Not the Age" campaign had to be withdrawn due to massive spending cuts.

John then went on to highlight the many developments the government had taken to ensure adequate care for older people in Scotland, giving particular emphasis to the concessionary travel scheme, council tax freeze, high amenity housing for older people and free personal and nursing care. John also went on to say that the government was looking to liaise with older people's organisations when considering the referendum on constitutional change for

Scotland and felt that older people's voices must be heard. John felt that the fact that people were entering old age happier and healthier was to be commended and that life expectancy was rising at a rate of 2 months every year.

John then took questions from the floor on such areas as the need to campaign and advertise the benefits which are widely available to older people to afford them a better standard of living; promotion of free personal care; the Change Fund and how it is monitored and implemented.

The second speaker of the day was Hugh Gaffney of North Lanarkshire TUC. Hugh greeted delegates by quoting from the Summerlee International Worker's Memorial "The Past We Inherit, The Future We Build" Hugh went on to talk about the fact that pensioners are now finding themselves in abject poverty and are being forced to go to bed in darkness and hunger and stressed that this was not acceptable in one of the world's richest countries. Hugh argued that society must do everything they can to eradicate the slogans "Either Eat or Heat"

and "No More Cuts, No More Poverty" as everyone should be treated equally as standard without having to beg and plead for a decent standard of living.

Hugh also spoke about his aspirations to put the story of Labour Party founder Keir Hardie back into the minds of people through a theatre production and

talks with NLTUC were ongoing on this matter. Hugh finished his talk by heaping praise on the No Pasaran Committee, remembering the sons and daughters of North Lanarkshire who volunteered and fought in the Spanish Civil War against fascism and for democracy, with particular emphasis being made to conference delegate John Milligan for his work in this area.

Hugh finished by taking questions from the floor on

such subjects as disability rights, the mobilisation of campaigning groups and challenges being made to local authorities on unfair charges.

Financial Report

Bill Allison delivered the accounts for the year 2011-2012 and remarked that the SPF bank balance was looking a lot healthier and that this was due to the hard work and commitment of the SPF Executive Committee. The accounts were considered and accepted by all in attendance.

Auditors' Report

A report from SPF auditors Watson & Co. was delivered to conference, confirming that an independent audit had been carried out and as specified therein showed no anomalies and the accounts were deemed to be in good and correct order.

This report was accepted by conference.

Election of Executive Committee 2012/2013

A list of nominations and their categories were delivered and the names of the Executive Committee were formalised and accepted by delegates.

Election of Standing Orders Committee John Milligan was nominated to serve on the SPF Standing Orders Committee. This nomination was agreed and accepted by conference and the delegate duly appointed.



The Year Ahead: Open Debate

Avril Anderson, East Kilbride Seniors Forum asked whether it was feasible to approach local authorities in relation to the Blue Badge Scheme asking that the need to submit a 28 page application form be withdrawn if a doctor's certificate stating disability was available.

Christine McGiveron, Individual Pensioner Member, asked that more be done in relation to the housing shortage and properly adapted homes for older and disabled people.

Dougie Molloy, East Kilbride Seniors Forum, asked was there a mechanism in which ring fenced money for older and disabled people could be more closely monitored.

Tommy Brennan, **Community Union**, called for a campaign on the two tier pension scheme which will be operational from 2016.

Elinor McKenzie, Individual Pensioner Member, remarked that no benefit or concession presently awarded to older people is safe. More must be done to highlight to younger people that older people are not only fighting for themselves but also for their futures too.

Mary McAleer, Clydebank Seniors Forum, remarked that a campaign to safeguard the concessionary travel scheme, in the long term, must be organised and negotiations taking place.

Bill Martin, Renfrewshire Seniors Forum, felt that there were too many organisations representing older people in Scotland and that the SPF should be looking at bringing all of these organisations together to speak in a united voice.

John McGiveron, CSPA, called for challenges in the local authority charges in relation to the Blue Badge Scheme. John felt that there was no consistency on these charges and that everyone under the scheme should write to their MSPs/MPs to challenge the evident variance in these charges.

21 Years of The SPF - A Celebration.

The conference was brought to a close with a PowerPoint presentation, created by the late Ronnie Campbell, and presented by Executive Committee member, Elinor McKenzie on his behalf.

The 15 minute presentation looked at the work of the Forum through a series of photographs, from its inception through to the present day, and highlighting past and present members, meetings with MP's and MSP's, campaigns and many other important events over the years.

Thanks were conveyed for the work put in to making such a fitting ending to the events of the day.

Vote of Thanks

Margaret Murdoch closed the conference and conveyed her thanks to all in attendance and to North Lanarkshire Council for hosting the event.

EXECUTIVE COMMITTEE MEETINGS WITH POLITICIANS

MEETING WITH ROSEANNA CUNNINGHAM MSP 5 October 2012

Cathy Leech, Rose Jackson and John McGiveron

Met with Community Safety Minister, Roseanna Cunningham, to discuss



issues of concern for older people and the implementation of adequate safety procedures to help them feel safe and secure in their home and wider communities. The Minister was very concerned about the importance of this issue and promised to arrange a meeting between the SPF and the Community Safety Unit of the Scottish Government to discuss this issue in greater detail and to perhaps look at arranging a joint initiative. These talks are still ongoing.

MEETING WITH KEITH BROWN MSP AND REPRESENTATIVES OF TRANSPORT SCOTLAND 12th December 2012

Representatives from the Scottish Pensioners' Forum met with Transport Minister, Keith Brown and Ruth Bishop and Andy Stevenson of Transport Scotland at



the Scottish Parliament in Edinburgh to discuss the concessionary travel scheme and other transport issues affecting older people.

Areas for consideration were:-

- The revamping of community railways stations to include disabled access and over-ramps and to ask what plans the Scottish Government had to ensure these requirements could be fulfilled
- Community transport and the withdrawal of services after peak times
- Lack of community transport in rural areas
- Adequate hospital transport schemes and improved services to allow for the changes in hospital outpatient care
- The long term security of the concessionary travel scheme and the inclusion of rail/ferry travel within the current programme(Cont'd)

Several issues were discussed in greater detail, including free ferry travel, with the Minister indicating that the ferry operators were already heavily subsidized to allow them to keep costs to a minimum and that Oban/Mull fares were already operating a

free service. The SPF requested that they be included in any future consultations taking place on the concessionary travel scheme and this was agreed.

Concessionary Travel Card Focus Group 20th February 2013

Further to the meeting with Keith Brown, Transport Minister, members of the Scottish Pensioners Forum were invited to engage in talks with ODS Consulting on behalf of the Scottish Government. The consultation was based around several key areas; the use of the concessionary travel card and the reasons for use, the time of day the card was most frequently used, distances travelled and ease of application. Members were also asked the most common procedures adopted by scheme operators when using the card and were alerted to the fact that

any issues or problems relating to the misuse of the card could be notified via a hotline number. After much discussion, SPF members took the opportunity to have their say on the many benefits to the government in relation to safeguarding the scheme, the most obvious being to health and wellbeing and in helping older people feel less isolated and more able to continue to interact within their communities and wider afield. The SPF also took the opportunity to discuss the possibility of a similar scheme on rail travel and this was noted.

Meeting with Health Minister Alex Neil 24th January 2013

Sheena Glass, Cathy Leech, Rosemary Smith, John McGiveron, Bill Allison and Jeanette Pieper met with Health Minister, Alex Neil, MSP at Holyrood, to discuss

matters relating to the health and social care needs of older people in Scotland.

Areas for consideration were:-

- Hospital transport and hospital waiting times and what can be done to make this time as minimal as possible.
- The implementation of home from hospital care packages and whether

these are correctly in place before discharging patients.

Discharging patients from hospital at unsocial hours.

Several issues were discussed in greater detail, including the Liverpool Care Pathway and whether there had been a supportive statement issued by the Scottish government on the matter, the new plans being put in place to cut down on unsociable hours patient discharge, initiatives by the Scottish Government to promote active ageing, Mr Neil promised to look into all of these areas and a follow up meeting was arranged for August 2013, when a representative from COSLA would also be in attendance.
