# **Chairperson's Foreword**

Once again it has been a very busy year for the Forum and we have seen some changes since our last conference, one of which resulted in my having been elected as Chairperson at the turn of the year. I would like to thank all of you, and your organizations, for your continued support during those changes.

We have attended a variety of events and conferences, providing information stalls to inform people just what it is we do. A particular highlight for me was at the STUC Congress in Dundee this year, where I met a group of students who were interested in our work and invited us along to deliver a talk at their college, as they are studying welfare rights and older people. I think this is an excellent opportunity for the SPF to engage with the youth of today.

We continue to pursue and defend the safety of our concessionary travel card and I was recently assured at a meeting with Gordon Brown that older people have reason to be confident that its safety is secured, despite fears to the contrary.

Sadly our pension continues to be one of the worst in Europe, despite the many promises we have been given over the years. We are now being told that as of 2016, a pension of £144 will be part of a new two tier pension scheme, so there is much more work to be done there.

Another worry for many of us has been the so called 'Bedroom Tax.' To clarify a point on this, this does not apply to households where all residents are of pensionable age, however it will apply to younger people who may be living with older relatives or carers. Please bear in mind that advice is always available through local authorities for anyone affected by this.

Health and Social Care issues remain a concern and many of us will have heard in the media of

cases of abuse and offences against the dignity of older people. The SPF are presently considering a campaign on this very issue.

So much has been done but there is still so much more to do. Working together we can achieve so much and my sincere thanks go to my colleagues for their unfaltering support through a busy year.

My special thanks must go to Eileen Cawley, our Administrator, who, although working only part time, does an excellent job and without her we would never be able to publish our reports, Newsletters and funding applications as well as everything else we do over the year.

I would also like to record my special thanks to Grahame Smith, General Secretary of the STUC, and his staff for the invaluable support that they give to the Forum.

Finally, I would like to thank all of you, for being part of an organisation that continues to fight for the rights of pensioners across Scotland and are the driving force behind what we are all trying to achieve, a better deal for older people.

# ANNUAL CONFERENCE 2013 REPORT

This year's conference took place on Tuesday 11<sup>th</sup> June 2013 at the City Chambers in Glasgow. Almost 200 delegates were in attendance all representing local pensioners' organisations, trade union retired members sections, as well as individual pensioner members from throughout Scotland. As always, their continued support and interest in the SPF's campaigning work was gratefully received.

Cathy Leech, SPF Chair, welcomed the delegates to conference and introduced Provost Sadie Docherty to deliver the civic welcome on behalf of Glasgow City Council.

#### **Civic Welcome**

In her address, Provost Docherty warmly welcomed all delegates to the City Chambers and remarked on how pleased she was that the Scottish Pensioners Forum had chosen to hold their 22<sup>nd</sup> Annual conference there. The Provost informed delegates that she felt older people wield a great sense of power in society and that the SPF were a force to be reckoned with when campaigning for the rights of older people. She went on to say that pensioners nowadays do not see themselves as old and their "wealth of experience in life" meant that



they were a vital part of the population and should have an input on how government is run, at both local and national level.

The Provost finished her address by calling on pensioners to continue their campaign to ensure

dignity and security in their later years and wished delegates a successful conference.

#### Mike Kirby, UNISON

Mike began his address by thanking the SPF for giving him the opportunity to speak particularly at a time when valuable frontline services were being cut which had a huge impact on workers as well as impacting heavily on older people, many of whom relied on these services on a day to day basis. Mike went on to say the government cuts to welfare budgets and services meant that to most people "austerity was all pain and very little gain" whilst millionaires receive tax cuts. Mike remarked that under the recent austerity measures implemented



by the government, there had been 30,000 local

authority job losses in Scotland alone and this figure was set to rise with more and more work being outsourced to the third sector, which further undermined workers' rights. Mike went on to say that the government was using the current economic crisis as a mechanism to stamp out workers rights and that, as this continued, retirement age would ultimately have to match state pension age, with the age of retirement being changed year on year.

Mike delivered some statistics from a recent government review on pensions and it was concluded that there would still be the likelihood that the pensioners of the future would be living in poverty.

Mike then took some questions from the floor on such areas as the need for stronger unions to help fight for both workers and service users and a call for a stronger labour movement to stand up to the political parties as financial assistance from unions has often been mismanaged by them

#### **Martin McElroy**

The second speaker of the day was Martin McElroy of STUC Youth Committee. Martin informed the conference delegates that over one third of trade



union members were due to retire over the coming years, and with only 4.1% of trade union members under the age of 24, this meant that a wealth of experience would be lost. Martin went on to say that recent austerity measures meant that there was a

possibility that people would be expected to deliver physically demanding jobs well into their 70s.

Martin then went on to say that there were many similarities between the battles that both younger people and older people face on a day to day basis and that he welcomed the fact that the pensioners of today are not only fighting for their rights but for those of future generations.

# Margaret Watt, Scotland Patients' Association



The final speaker of the day was Margaret Watt of the Scotland Patients' Association. Margaret addressed conference by delegates informing that as stakeholders in the NHS, older people are as entitled to proper their younger care as counterparts and if there was a

feeling that they had not been properly cared for, or misdiagnosed, it was their right to ask for a second opinion and make their voices heard.

Margaret engaged in a lengthy question and answer session with delegates on all aspects of health and social care for older people including care provision in residential care, home from hospital package, proper care plans and the Liverpool Care Pathway.

#### **Financial Report**

Bill Allison delivered the accounts for the year 2012-2013 and remarked that the financial situation SPF at the was much healthier due, in part, to grants received from Comic Relief. Bill went on to say that this healthier balance should not be taken for granted and that the SPF would continue to generate funds to carry out the work needed to ensure that pensioners' voices would be heard. The accounts were considered and accepted by all in attendance.

#### Auditors' Report

Eileen Cawley delivered a report from the auditors:-

'An independent examination of the accounts of the Scottish Pensioners' Forum was carried out by Watson & Co, Hamilton on 16<sup>th</sup> May 2013. After considering the information given to us, we could find no reason to think that these accounts were not a true and accurate record of accounts for the year 2013.'

This report was accepted by conference.

#### Election of Executive Committee 2013/2014

A list of nominations and their categories were delivered and the names of the Executive Committee were formalised and accepted by delegates.

Election of Standing Orders Committee Maureen Gardner, Jimmy Miller and Mary Murray were nominated to serve on the SPF Standing Orders Committee. These nominations were agreed and accepted by conference and the delegates duly appointed.

# The Year Ahead: Open Debate

**Jimmy Miller, GMB** remarked that as the SPF Conference was the second largest event outwith the Older People's Assembly, more MPs, MSPs and councillors should be attending.

Les Anderson, South Ayrshire Seniors Forum indicated that she felt that the SPF should hold a position on the misuse of money through the Charge Fund.

# John McAllion, Dundee Pensioners

Forum, remarked that the SPF should recruit more volunteers to speak out against Community Care in Scotland as MSP's were not doing anything about it.

Mary McAleer, Clydebank Seniors Forum, called for a costing exercise to be done on care homes and their justification in charging such exorbitant sums of money. Mary also remarked that there should be on the spot visits to ensure management was at an optimum level.

#### Rhona Young, Clydebank Seniors Forum,

said that the NHS was free at point of delivery however for certain elements of care, pensioners were being charged hundreds of pounds. Rhona went on to say that Clydebank were very successful in lobbying MP's/MSP's to get their point across and urged other groups to do the same **Elinor McKenzie** indicated that the telehealth/telecare plans were 'health on the cheap' and that she had grave concerns in relation to these practices.

Gordon Samson, Dundee Pensioners Forum, called for the lobbying of organisations by the SPF and the need for the organisation to be strengthened and make their voices heard. Gordon suggested a dual membership between the SPF and Dundee Pensioners Forum.

John Milligan, Individual Pensioner Member, felt that the SPF were to be applauded for their work and standing by the legacy of a generation by campaigning at grass roots level. John said that society has to get up off of its kness and can do this by talking and encouraging g the younger generation tot ake up the cause.

**Tommy Brennan, NLTUC**, remarked that the SPF had the capability to be the biggest pressure group in Scotland and called for a recruitment campaign to increase membership to the SPF. Tommy went on to say the reality of a two tier pension scheme would be in place by 2016 and something must be done to stop this as pensioners in the UK were already receiving the second lowest state pension in Europe.

# Vote of Thanks

Cathy Leech closed the conference and conveyed her thanks to all in attendance and to Glasgow City Council for hosting the event.

# Meeting with Health Minister Alex Neil 19<sup>th</sup> September 2013

Recently, members of the Scottish Pensioners' Forum Executive Committee met with Health Minister, Alex Neill MSP, and representatives from COSLA, at Holyrood, to discuss various issues surrounding the health needs of older people, including home from hospital care packages and hospital transport needs.

Areas for consideration were:-

- Calls for the Minister to speak on behalf of the SPF and older people to try to revaluate and stop the closure of day centres for older people across Scotland which were a much needed lifeline for many.
- That was there any plans for a Scottish Government initiative which

would look at promoting active ageing, which in turn could have a positive effect on the health budget in the long term.


- The Scottish Government's position in support of the Liverpool Care Pathway
- The need for all older people to be supplied with personal alarms, if needed, free of charge as there are presently varying rates across all local authorities.
- A call for all renewals of disabled blue parking badges to be met and renewed, without condition, for older people with health issues.




