#### **Chairperson's Foreword**

In my third term as Chairperson, it has proved yet another busy year for the Forum with our volunteers going out and about across the country hosting outreach meetings and attending a variety of conferences and events to ensure older people's voices are heard.

Throughout the year we have engaged in a series of talks with the Scottish Government on the concessionary travel scheme consultation and in turn launched a campaign 'Hands Off Our Bus Pass' to challenge the proposed changes to the age of entitlement as set out in the consultation. We feel that any changes would have a drastic impact on a person's wellbeing in terms of both their physical and mental health.

As set out in last year's annual report, the issue of health and social care continues to be a concern for older people with loneliness and isolation being a major worry. During the past year, the SPF has been going out and about across Scotland to hear your views on how loneliness and isolation impacts on you, both within your communities and on a more personal level and we aim to deliver a similar programme throughout 2018.

What we have found from our work is that young or old, loneliness and isolation does not discriminate on the basis of age. It's only in recent years we have come to realise how big the issue is and how chronic loneliness can be to our health. Millions of people are affected by it yet there is still such a stigma surrounding it that it only serves to exacerbate the issue.

During mental health awareness week, the SPF took part in a panel discussion on the subject and helped highlight the similarities between young and old when considering the common causes that lead to loneliness and isolation and during this Scottish Government Year of Young People the SPF will be working with STUC equalities groups to expand on this.

I hope that you will see from the report that we have been working hard to ensure that the voices of our members are heard and over the coming year will continue to do so. We are pleased that the newly formed Older People's Strategic Action Forum will give us, and our members, a direct link to government and we look forward to working with the Minister for Social Security and Older People and other older people's organisations and groups to help implement change.

It is at this point that I would like to thank all of you for being part of an organisation that continues to fight for the rights of older people across Scotland. We are only as good as our members and your continued support allows us to carry out the work on what we are all trying to achieve, a better deal for older people.

Motions to conference seen an endorsement that the SPF would call on trade unions who presently had no retired members' branches to introduce them in order to help combat loneliness and isolation in retirement.

# **OUR WORK THROUGHOUT THE YEAR**



## MEETING WITH JEANNE FREEMAN, MSP Minister for Social Security and Older People

Members of the Scottish Pensioners' Forum, along with members of Scottish Seniors Alliance, met with Jeanne Freeman MSP at Holyrood on 13th September 2017 to discuss issues of concern for older people. In a joint letter previously sent from SPF/SSA, both organisations listed items for discussion however due to time constraints, the following issues were prioritised:

- A Minister for Age, Ageing and Older Peoples issues. The SPF was informed that it was the First Minister's remit to decide which Ministers she would like in place and who would be best suited to the post. Ms Freeman advised that her Ministerial portfolio included working with older people.
- The reinstatement of The Older People's Consultative Forum. The Minister indicated her support for a consultative forum which could deal with such issues as the Winter Fuel Allowance and fuel poverty as well as any other matters presently being devolved from Westminster .Ms. Freeman indicated that it was her intention to hold the first meeting of the new group in November 2017 and that it's remit would in no way replicate the work already being done by the Cross Party Group on Older People, Age and Ageing, chaired by Sandra White MSP.
- Fuel Poverty and the Winter Fuel Allowance. Evidence was produced in support of increasing this
  allowance. The Minister replied that eleven benefits had been devolved to the Scottish Government,
  including the Cold Weather Payments and Winter Fuel Allowance. She advised that the transfer of funds
  from Westminster in 2019 would be based on the spend undertaken in 2018, so there would be no new
  monies linked to the transfer. Ms Freeman also raised her concerns surrounding child poverty. It was
  stated that the only benefits to increase would be those already mentioned in the SNP Election
  Manifesto, i.e. Carers' Allowance, and extending winter fuel support to families with disabled children.
- Funeral Poverty. The Minister acknowledged the disparity of charges throughout the country and the problems of poor practice in many areas. Any harmonisation of costs should be downwards and therefore an increase in prices should not be seen. The Scottish Government is encouraging a social enterprise approach regarding funeral directors and the SPF was advised of such a partnership in East Ayrshire. At the moment many people have pre-paid funeral plans, and many more think they have put enough money aside to cover costs however as the small print shows, this is not always the case. Currently an additional payment of £700 is subject to intrusive questions. Angela Constance MSP is working on social security payments to be effected by 2019 whereby if someone is eligible based on the qualifying criteria then the money will be released immediately. If someone is on a low income then they will know when making arrangements what they are entitled to. The Minister emphasised that social enterprise was the favoured way forward rather than any form of 'nationalisation'.
- Concessionary Travel Scheme. The Minister referred to the SNP Election Manifesto commitment to extend eligibility to other groups. The SPF restated its policy of retaining eligibility for those aged 60+ and argued that it should be extended to cover rail and ferry travel, and in addition to this there should be improvements made to rural services in order to help combat loneliness and isolation. The Minister said she would pass the SPF's comments to Transport Minister Humza Yousaf MSP although she herself believed that the age for concessionary travel should be pegged to state pension age. 65 and rising.



#### Delegates at the SPF Annual Conference in Dundee adopted the following document on the Dignity and Rights of Older People in Scotland into SPF standard policy and practice on Tuesday 13<sup>th</sup> June 2017

Under Article 1 of the UN Universal Declaration of Human Rights (1948) it states "All human beings are born free and equal in dignity and rights"

The SPF believes that this right should not diminish throughout an individual's natural life cycle as, all too often, when people age, there is a common misconception within society that their contribution becomes less valuable than that of their younger counterparts.

This policy sets out that any movement towards denying older people their basic human rights on issues affecting their everyday lives on the basis of age is unacceptable and to this end calls for:

- Respect for older people to take charge of their own affairs, or if necessary, by their chosen representative if they are no longer able to do so for themselves
- That older people have the opportunity to actively participate, and to speak, for themselves on decisions affecting their overall wellbeing
- That older people have access to information through language and methods of communication that they fully understand
- That older people have the right to access proper health care benefits and treatments which could enhance their quality of life
- That advanced statements expressing the personal choices of older people on their health care in later life be taken into consideration when they can no longer express themselves clearly
- That care packages in later life be adapted to cater for individual needs and not on a standardised 'one size fits all basis'
- The right for older people not to be abused or disrespected in any way or being made to feel invisible or incompetent when carrying out everyday tasks
- The right of an individual to be free from the threat of violence due to their age or vulnerability
- Support for older people to allow them to maintain a good standard of personal hygiene and appearance
- In line with the NPC Dignity Code, comfort, consideration, inclusion, participation, stimulation and a sense of purpose on all issues affecting an older person which could help enhance their quality of life
- That there be no barriers to participation for older people, if desired
- That there is respect for an individual's preferences, routines, customs, faith, cultural differences, disability, sexual orientation and all other needs appertaining to their sense of self
- A proper mechanism for older people to address concerns and make complaint without fear of recrimination
- Older people have the right to privacy
- Older people have access to educational opportunities which could help improve their quality of life.
- Older people have the right to employment opportunities, both paid and voluntary
- The right of older people not to be discriminated against in the workplace as a consequence of age
- The right of older people to be afforded dignity and respect in all verbal and written communications
- That the rights of older people, as set out under the UN Universal Declaration of Human Rights are respected and adhered to as standard practice

# **CROSS PARTY GROUP ON OLDER PEOPLE. AGE AND AGEING**

The Scottish Pensioners' Forum continue to be represented on the Scottish Government Cross Party Group on Older People, Age and Ageing, convened by Sandra White MSP.

Recent discussions have looked at the integration of health and social care and its developments, concessionary travel, community safety and nuisance and bogus callers.



## OLDER PEOPLE'S STRATEGIC ACTION FORUM

After numerous meetings between ourselves, SSA and Minister for Social Security and Older People, Jeane Freeman MSP, on the reinstatement of the former Older People's Consultative Forum the first meeting of the newly formed **Older People's Strategic Action Forum** took place in November 2017. This newly formed group will once again give older people and their representatives a direct link to government on issues affecting them in their everyday lives. More information will be made available after future meetings (the next being held in June 2018) to adopt a potential framework for joint action in order to maximise older people's contribution to policy making in Scotland.

# **CONSULTATION ON THE CONCESSIONARY TRAVEL SCHEME**



The Scottish Government Consultation on Free Bus Travel for Older and Disabled People and Modern Apprentices closed on 17<sup>th</sup> November 2017. The SPF launched a campaign which we took around the country and for which we received support from our affiliates and MSP's, in particular Unite Glasgow Retired Members' Branch,

who had also launched a similar campaign.



Up until the closure of the consultation, the SPF continued to meet with Transport Scotland to put forward the views of our members on how to preserve the scheme at the present age of 60 and above.

As well as this, the SPF were scheduled to meet with Transport Minister, Humza Yousaf, on a number of occasions to discuss the scheme however these had to be cancelled by his office due to other commitments. The response to the consultation has not yet been published and we hope to have the opportunity to meet with the minister prior to this.

Over 50 members and affiliates from across Scotland joined us on the day and guest speakers included Richard Leonard MSP, Claire Baker MSP, Derek Young, Age Scotland and SPF Chair Rose Jackson, Treasurer Maureen Gardner and Executive Committee member, Elinor McKenzie also made a contribution.

As well as the valued contribution made by our speakers more than a dozen MSP's came out to meet with our representatives and to listen to our concerns.

## **SPF/SSA JOINT PARLIAMENTARY RECEPTION**



On 22<sup>nd</sup> May 2018, the Scottish Pensioners' forum, along with our colleagues in the Scottish Seniors Alliance, held a joint parliamentary reception in the Garden Lobby of the Scottish Parliament. Hosted by Ms. Sandra White MSP, Convenor of the Cross Party Group on Older People, Age and Ageing and with contributions from Ms Jeane

Freeman, Minister for Social Security and Older People, Rose Jackson, SPF chairperson and Bill Johnston, SSA Chairperson, the reception was a celebration of both organizations over the years and their input into the

development of the Older People's Strategic Action Forum giving older people a direct link to government on issues affecting them.





## A Connected Scotland: Consultation on Loneliness and Isolation



## SPF OUTREACH WORK TO HELP TACKLE LONELINESS AND ISOLATION
