SPF Make Fresh Demands to the BBC over TV Licence Issue

BBC's recent response the announcement to increase the cost of the TV licence by £3 per year whilst cutting, amongst other things, vital news services, the Scottish Pensioners' Forum are once again calling on the BBC to rethink their decision to means test the TV licence for over 75's from June 2020.



Maureen Gardner. SPF Chair argued:-

"One of the main reasons

the BBC have given for reaching their decision on being forced to means test the TV licence for over 75's was the potential loss of jobs and services that maintaining the present system could bring. However, what we have seen in recent weeks is not only an increase to the cost of the TV licence but also the loss of 450 jobs. Many of the news services, which are often an essential lifeline in keeping older people connected with the outside world, have also been withdrawn - how is this fair?"

The SPF have contacted the BBC to ask them to rethink their decision on means testing and to acknowledge the devastating impact the removal of this concession could have on many older people. Whilst the

appreciates that the BBC's position is not ultimately one their own choosing, the power to revoke decision the before the present scheme ends in May lies firmly with them.



"Up to 40,000 older people across Scotland, as well as many more over other parts of the UK, are now being forced to choose on whether to eat, heat or watch television, this is not factitious but a shocking reality and they deserve better."

With levels of loneliness and isolation in older people reaching record heights, the decision of the Westminster Government to outsource the capacity to change social policy to third parties could not come at a worst time. The SPF demands that they retake ownership of the scheme and continue to offer the concession to all older people over 75 as is the case at the present time.

The SPF will continue to work with other older

people's organisations across the UK in campaigning and demonstrating this important issue and will keep our members updated



on all future developments.

SPF Celebrate UN International Day of Older Persons 2019

On 1st October 2019, the SPF held their yearly demonstration outside the Scottish Parliament to mark United Nations International Day of Older Persons, Supported once again by our affiliates and friends, this year's theme "The Journey to Age Equality" drew attention to the existence of inequalities in old age, many of which are a result of accumulative disadvantages throughout a person's life.



Maureen Gardner, SPF Chair, gave a heartfelt speech on her own experiences growing up and the inequalities she faced throughout her life, speaking mainly on education, religious bias and the gender pay gap. (A full transcript of Maureen's speech is available upon request).

Retired Members' Branch and campaigners from the WASPI campaign. As has been common practice over the years, Convenor of the Cross Party Group on Older People, Age and Ageing, Sandra White MSP put forward a motion to parliament on behalf of older people in Scotland

SPF General Election Hustings, STUC Centre, Glasgow

To coincide with the launch of our General Election Manifesto, the SPF held a hustings in Glasgow with representatives from all the main political parties in attendance: Tony Curtis, Conservative Party; Pam Duncan-Glancy, Labour Party; Marion Fellows, Scottish National



Party; Elaine Gallagher, Green Party and Susan Murray, Liberal Democrats. The lively debate was chaired by SPF Vice Chair and UNISON Scotland representative, Rose Jackson and issues put to the panel included the differing and unfair pensions systems; digital inclusion; post office and bank closures; universal credit changes and the free TV licence for over 75s.



Out and About

Since our last newsletter the SPF have been in attendance at several events including the STUC Black Workers' conference and the STUC Disabled Workers conference in Clydebank, Glasgow's' Golden Generation AGM in Glasgow, as guest speaker at Dementia in the Workplace events in Inverness and Glasgow, Scottish Policy Conference on Older People's Wellbeing in Scotland: Next Steps following the Fairer Scotland Framework for Older People and the Scottish Older People's Assembly.

As well as this we have also held our yearly demonstration at the Scottish Parliament to celebrate UN International Day of Older Persons and engaged in talks with Transport Scotland on the National Transport Consultation through our work with the Scottish Government's Older People's Strategic Action Forum. We also continue to serve our members through our work on the Cross-Party Group on Older People Age and Ageing and the Cross Party Group on Funerals and Bereavement.

Prescription Delivery Charges

As recently highlighted in *Pharmacy Business*, Boots have begun implementing a charge of £5 for new patients who opt to have their deliveries made from their stores. However, the pharmacy chain has indicated that they would continue to offer free delivery to those they deemed most vulnerable with exemptions from charges including end of life care patients and those with an urgent clinical need referred through their GP. Prescriptions ordered online and through the Boots app remain free of charge. Boots Pharmacy Director Richard Bradley said:



"Community pharmacy is unquestionably facing challenges and we need to adapt our offer to respond. As a result, we have invested heavily in digital technologies to offer a free, easy to use service for delivery of repeat prescriptions ordered online."

As many older people do not have access to digital and online services, this may well be another charge they will have to face if they are unable to get out and about. The Scottish Pensioners' Forum will be keeping a close eye on developments and in the meantime ask Boots to include older people as a category within their exemption criteria.

Winter Fuel Allowance

At a meeting with then Cabinet Minister for Social Security and Older People, Jeanne Freeman MSP, the Scottish Pensioners' Forum raised the issue of the Winter Fuel Allowance. During our discussion, we pointed out that the Allowance had remained at the same level of £200 per household since it was first introduced, yet domestic heating charges had risen substantially since then. Ms. Freeman indicated that it was her intention to raise this allowance in line with inflation rom 2020.

As the Winter Fuel Allowance, as well as other benefits, has recently become the responsibility of the Scottish Government, we have asked for assurances from the present Cabinet Minister for Social Security and Older People that this will still be the case. We will keep our members informed once we have received a satisfactory response.

SPF Annual Conference, Glasgow 2020
